

## **TITLE I School Parental Involvement Policy**

Title I regulations require that each school served under Title I jointly develop with and distribute to parents of participating children a written involvement policy agreed on by the parents that describes the requirements of SEC. 1118. At the Annual Title 1 Parent Meeting, dates for future meetings were discussed and will be collaboratively developed to ensure it meets the needs of Title 1 families.

At the Annual Title 1 Meeting in October 2019 the Title 1 Parent Involvement Policy was reviewed and feedback from families was elicited.

Dr. Lena Edwards Academic Charter School provides progress updates to Title 1 students at least three times per year, to include fall, winter and spring. This will include progress on assessments for Reading and Math.

- **E. BUILDING CAPACITY FOR INVOLVEMENT** To ensure effective involvement of parents and to support a partnership among the school involved, parents, and the community to improve student academic achievement, each school and local educational agency assisted under this part
  - 5. Title 1 students will be provided with support for literacy and mathematics 3-5 days per week in a small group setting. Additionally, before/after school Title 1 program options will be available to support students' academic success.

6. Shall provide materials and training to help parents to work with their children to improve their children's achievement, such as literacy training and using technology, as appropriate, to foster parental involvement;

Throughout the 2019-2020 school year, families will be invited to Parent University workshops focused on strategies to support literacy and math achievement, as well as training on technology programs including Google Apps for Education.

- 7. Shall educate teachers, pupil services personnel, principals, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school;

- 11. May provide necessary literacy training from funds received under this part if the local educational agency has exhausted all other reasonably available sources of funding for such training;
- 12. May pay reasonable and necessary expenses associated with local parental involvement activities, including transportation and childcare costs, to enable parents to participate in school-related meetings and training sessions;

13.	May train parents to enhance the involvement of other parents;
(	May arrange school meetings at a variety of times, o conferences between teachers or other educators, who work directly with participating children, with parents who are unable to attend such conferences at school, in order to maximize parental involvement and participation;
15.	May adopt and implement model approaches to improving parental involvement;
	May establish a school wide parent advisory council to provide advice on all matters related to
l	parental involvement in programs supported under this section;
	May develop appropriate roles for community-based organizations and businesses in parent involvement activities; and
	Shall provide such other reasonable support for parental involvement activities under this section as parents may request.
