In accordance to the CDC guidelines and the NJ Road to Reopen Schools, cleaning and sanitizing surfaces are at the core of the tasks to mitigate the spread of COVID-19. Funds will be used to purchase materials and for payment for staff and cleaning companies to service the campus. DLEACS has a facility safety plan crafted by PS&S (Paulus Sokolowski & Sartor) a firm offering multi-disciplined, full-service architecture, engineering, design, environmental and surveying consulting services. The facility safety plan identifies a number of items required to prevent the spread of the virus. Among these are desk shields and temperature scans. Additionally, to prevent the spread of the corona virus, we must ensure social distancing. This may include limiting group sizes, creating cohorts, keeping students six feet apart, restricting nonessential visitors, and closing communal spaces. The following procedures will be in place across all our building: Three (3)-sided clear desk partitions will be used on student desks to help maintain social distancing. Signage throughout the campus will be visible to guide student, staff and visitors.

2.
